As CBO you will recommend remedial measures where there are deficiencies when needed ... you will develop strategies provide direction and hold the responsibility for approval of such areas as By-Law Standards, Development Engineering, accurate and timely approval of subdivision plans and redevelopment... you will also oversee Liquor License approvals.

Qualifications: Ideally you have more than 10 years leadership experience in senior administrative or management roles in government or similar organization with comprehensive knowledge of building, plumbing and fire codes

- You have a post-secondary education in the field of architecture, civil engineering or related discipline.
- You are a Certified Building Code Official designation as granted by the Ontario Building Officials Association.
- You are very likely registered as a P.E.O. as a Civil Engineer (P. Eng.) or an O.A.A. as an Architect.
- You have a strong working knowledge of the various by-laws and legislations including the Building Code Act, Planning Act EVP Act plus Zoning and Property Standards have a long history of building consensus among elected officials, staff, other levels of government and residents.
- You understand the issues and challenges facing municipalities today and are familiar with best practices in Building and Development Services, financial management, administration, operations, human resources, and governance.
- You have a successful track record of accomplishments and possess well-developed skills in communication, problem solving and, most importantly, leadership.
- You should share the city's goal to develop a diverse workforce that is representative, at all job levels, of the citizens we serve.
