Responsible for the examination and analysis of building services, on-site sewage systems, mechanical and plumbing drawings, specifications, calculations and reports for compliance with the prescriptive provisions of the Building Code Act or Building Code, as amended, related regulations and applicable laws for the purposes of issuing building permits. Evaluates the Energy Efficiency designs of the building mechanical systems and verifies all submitted forms, energy modeling reports and calculations to be compliant with Building Code Act or Building Code, as amended. Provides assistance/expertise and code interpretations to the public, developers, builders, design professionals, etc., and liaises with department staff, internal departments and external government/private sector agencies, where required. Performs HVAC, plumbing, and site services design review and evaluation of calculations as related to all type of building system's designs. Calculates plumbing fees. As directed, performs joint site inspections as construction relates to approved alternative solution. Responds in a timely manner to enquiries and researches and prepares reports as reguired, include those associated with alternative solution proposals.
