The Building Inspector is also appointed as a By-Law Enforcement Officer and may investigate complaints and enforce municipal by-laws under the supervision and direction of the CBO and/or Deputy Chief Building Official.

## Summary:

Reporting to the Chief Building Official (CBO), the Building Inspector is responsible for compliance with provisions of the Ontario Building Code/Act, Ontario Building Code/Regulations, and all other applicable laws while performing efficient delivery of building/septic inspections from the initial inquiry, examination of drawings, through to compliance inspections and recordkeeping. The Building Inspector is also appointed as a By-Law Enforcement Officer and may investigate complaints and enforce municipal by-laws under the supervision and direction of the CBO and/or Deputy Chief Building Official.

## **Position Roles and Responsibilities:**

- Provide building requirement information to applicants to ensure compliance with Ontario Building Code
- Participate in communication with various professionals in the building community, other municipal departments, government and elected officials
- Assist in the drafting and coordinating of responses to public and/or legal inquiries regarding work orders, zoning compliance, etc.
- May be required to attend hearings, meeting of council/committees and the Ontario Municipal Board, gives evidence before tribunals as necessary in response to appeals, claims and/or prosecutions as requested
- Will assist in the supervision of and delegation of work to other employees in the Department from time to time
- Work collaboratively to ensure efficient delivery of municipal services and excellent overall customer service
- As directed, may assist in the issuance of permits (building/occupancy) in accordance with the Ontario Building Code and other applicable legislation, advising applicants of additional permit needs when appropriate
- Assist in providing consistent and professional building, plumbing, heating and septic application, approval, inspection, and compliance services
- Under the CBO's authority, participate in performing various inspections as directed and may assist in investigating complaints and maintaining deficiency lists
- Keeps abreast of new and changing aspects of the profession (legislation, regulations, procedures) by attending seminars, workshops, chapter meetings, conferences, and courses, educating parties on these relevant updates as required

#### **Working Conditions:**

- 35 hours per week
- Works 50% in an office environment and 50% on construction sites
- Frequent interruptions

- Physical Demands: walking, climbing ladders/stairs, bending/stooping/crouching
- Frequently lifts materials and objects less than 2kgs
- May be exposed to hazards such as noises, heights, overhead construction, sharp objects, chemicals, odors, fumes, heavy equipment, trenches and excavations
- Required to uses senses to test various alarms and conduct inspections
- Inspections outside of regular work hours may be required
- Travel within municipality required
