The Opportunity

Reporting directly to the Supervisor, Plans Examination, this role reviews and approves plans submitted for all Part 3 and Part 9 building permit applications, this includes all residential, commercial, and institutional buildings applications.

As the Plans Examiner, Zoning, you will perform the following duties, including but not limited to:

- Responsible for ensuring permits are in compliance with the Towns Zoning By-law and all other applicable laws, standards and regulations. Ensure notes and corrections are clearly identified on the approved building permit documents.
- Ensure that process reviews are correctly entered into the Towns permit administration database AMANDA. Respond to the general public, applicants, design professionals and external agencies both in writing and verbally with respect to general enquiries and plan review deficiencies Assist applicants with bringing their application into compliance with applicable regulations. Attend meetings with clients or internal Departmental Staff to review potential proposals/applications and represent the Division in these meetings.
- As part of the Division's ongoing process improvements, assist in the development of Divisional SOP's/ Practice Bulletins and process improvements.
- Be able to work independently and as part of a larger team to achieve the overall objective of the Town and the Division to ensure that all buildings constructed in the Town are safe for the building owners/occupants and members of the public while ensuring compliance with the Zoning By-law.
- Responsible for verifying Building data with respect to fees and Development Charges.
