Building Inspector/By-Law Enforcement Officer

The Corporation of the Township of Bonfield Building Department is currently accepting applications for the position of Building Inspector/By-Law Enforcement Officer. Reporting to the Chief Building Official, the Building Inspector/By-Law Enforcement Officer will inspect buildings under construction to ensure compliance with the Ontario Building Code Act, its regulations and all other applicable legislation. The Building Inspector/By-Law Enforcement Officer will enforce all by-laws and Acts as assigned to the By-Law Enforcement Officer.

Preference will be given to candidates who have the following experience:

- Five years related experience which includes at least 2 years performing municipal building inspections and reviewing permit applications for a minimum of Part 9 Buildings and Part 7, Plumbing.
- Formal academic training in Architectural/Civil engineering or equivalent or construction technology or equivalent would be an asset.
- Successful completion and registration of examinations administered by the Ministry of Municipal Affairs and Housing including General Legal, House, HVAC House and Plumbing House are the minimum requirements with the willingness to obtain qualification examinations and registration for Small Buildings, Large Buildings, Plumbing All Buildings, Building Services, Building Structural and Complex Buildings.
- Have a thorough working knowledge of the Ontario Building Code with an emphasis on residential buildings, HVAC and plumbing systems.
- Shall be able to read and interpret blueprints and construction drawings
- Experience in By-law and Property Standards Enforcement and P.O.A
- Hold a valid Class G driver's license and a clean driver's abstract.
- Sound working knowledge of computers including MS Office programs and GIS.
- Excellent verbal and written communication skills and excellent interpersonal, public relations, organizational and time management skills.

This is a Union position and is a 40 hours/week Part Time position 7 month per year, May-November, with the possibility for advancement. Compensation for this position is \$30.78 per hour as set out in the Collective Agreement.
